Subject: Open UGA Board of Directors Position

Dear Club Representative:

The Nominations and Recognitions Committee of the Utah Golf Association (UGA) is accepting nominations from UGA Member Courses/Clubs for *one* open position on the Utah Golf Association Board of Directors. In order for nominations to be considered member clubs must complete and return the enclosed UGA Nominations Form no later than Friday, August 2, 2019. Nominations may be mailed to the Utah Golf Association (see address above) or e-mailed to Jacob Miller at jacob@uga.org. If no nominations are received from member clubs the Nominating Committee shall provide a list of candidates for director to the board of directors. Once the nominations are provided, the directors shall be selected from among the nominated candidates by the sole vote of the UGA Board of Directors.

Newly elected directors shall serve a three (3) year term commencing at the beginning of the next fiscal year (Nov 1). No director shall be eligible for re-election after having served for three (3) consecutive elected terms without at least a one-year absence from the board. When a vacancy on the board occurs with time remaining on the vacant term, the board has the option of 1) selecting a replacement director to complete the term with two additional terms available, or 2) selecting a replacement for a full term with two additional terms available. Under no circumstances will a director be eligible to serve more than three full terms (9 years) without a one-year absence from the board.

If a nominee is not selected in the year they were nominated, their nomination will remain in consideration for the next two years' worth of nomination and election processes if not withdrawn. Available board positions in the next three years: 2020 – one (1) position, 2021 – multiple positions, 2022 – multiple positions.
