- 1. TEE MARKERS:** Senior Division will play from the BLUE UGA TEE MARKERS
Super-Senior Division will play from the WHITE UGA TEE MARKERS
Legends Division will play from the GRAY TEE MARKERS
- 2. FAIRY RING FUNGUS DAMAGE AND SEASONAL GROUND CONDITIONS:** Ground conditions that are thin or bare due to fairy ring fungus, drought or winterkill have not been marked as Ground Under Repair nor will be played as such. If a player believes the condition may warrant relief, he may play two balls, following the procedure in Rule 20.1c3, or may request a ruling if a rules official is readily available.
- 3. IN-COURSE OUT OF BOUNDS:** The white stakes between holes #5 and #6 determine the out of bounds for the play of hole #6 only. These stakes are immovable obstructions during the play of any other hole and are fixed boundary stakes during the play of hole #6.
- 4. 150 YARD STAKES** are deemed to be immovable obstructions.
- 5. HOLES 15 & 18:** The orange fence down the right side of #15 and the left side of #18 defines *Ground Under Repair*, and the fence itself is part of the *Ground Under Repair*. To take free relief from the *Abnormal Course Condition*, it must be known or be virtually certain that the golf ball lies in or touches the *Abnormal Course Condition*.
- 6. YOUNG TREES** identified by Orange or Green Stakes are *no play zones*:
 - If a player's ball lies anywhere on the *course* other than in a *penalty area* and it lies on or touches such a tree or the tree well or such a tree or tree well interferes with the player's *stance* or area of intended swing, the player must take relief under Rule 16.1f.
 - If the ball lies in a *penalty area*, and interference to the player's *stance* or area of intended swing exists from such a tree, the player must take relief either with penalty under Rule 17.1e or with free relief under Rule 17.1e(2).
- 7. SCORING AREA:** Is defined by the painted lines around the scoring tent. The scoring tents are temporary immovable obstructions, and the lines define the TIO.
- 8. OUT OF BOUNDS** is defined by inside edge of curbs, white stakes, property fence posts/pillars and telephone poles at ground level and white lines that connect them. When defined by a white line the line itself is out of bounds. If a ball crosses a public/private roadway and comes to rest on another part of the course, the ball is considered to be Out of Bounds. The driving range is out of bounds and is defined by the course side edge of the telephone poles. The maintenance road to the left of #10 is deemed not to be a road, it is an immovable obstruction. The course side edge of the telephone poles left of #18 supporting the netting define out of bounds.
- PACE OF PLAY:** UGA Checkpoint Policy (See timing sheet online for times)
- 9. TIES:** If there is a tie for the top spot in any division, a hole-by-hole sudden death playoff will follow play. Announcements will be made at the clubhouse.
