Dear Club Representative:

The Nominating Committee of the Utah Golf Association "UGA" is accepting nominations from UGA Member Courses/Clubs for *three* open positions on the Utah Golf Association Board of Directors. For nominations to be considered, member clubs must complete and return the enclosed UGA Nominations Form no later than August 1, 2021. Nominations may be mailed into the Utah Golf Association (see address below my signature) or e-mailed to Jacob Miller at [jacob@uga.org](mailto:jacob@uga.org). The Nominating Committee may also provide candidates for director. Once the nominations are provided, the directors shall be selected from among the nominated candidates by the sole vote of the UGA Board of Directors.

Newly elected directors shall serve a three (3) year term commencing at the beginning of the next fiscal year (Nov 1). No director shall be eligible for re-election after having served for three (3) consecutive elected terms without at least a one-year absence from the board. When a vacancy on the board occurs with time remaining on the vacant term, the board has the option of 1) selecting a replacement director to complete the term with two additional terms available, or 2) selecting a replacement for a full term with two additional terms available. Under no circumstances will a director be eligible to serve more than three full terms (9 years) without a one-year absence from the board.
